

**BRIDGEND COUNTY BOROUGH COUNCIL**  
**PROPOSED AMENDMENT TO PARKING**  
**CHARGES**

Bridgend County Borough Council propose to amend the parking charges in those car parks regulated by the Bridgend County Borough Council (Off-Street Parking Places) Civil Enforcement) Order 2013 that are detailed below. The existing and proposed charges are set out as follows.

It is also proposed that an out of hours release fee of £50.00 will be introduced at Rest Bay Car Park, Brackla 1 Multi Storey Car Park, the Rhiw Multi Storey Car Park and the Bowls Hall Car Park.
